**JOINT MOTION TO CONTINUE EVIDENTIARY HEARING AND FOR EXTENSION  
OF TIME FOR VEOLIA TO RESPOND TO COMPLAINT**

Respondent Veolia Energy Kansas City, Inc. (“Veolia”) and Complainant Commerce Tower Group, LLC’s (“CTG”) are actively seeking to resolve the issues raised in CTG’s Formal Complaint. To that end, the parties request that the evidentiary hearing scheduled for October 23, 2015 be continued to November 6, 2015.

The parties also request that the filing deadline for CTG to file a list of the witnesses to appear at the hearing, the order in which they will be called, the order of party cross examination for each witness, and the order of opening statements of October 19, 2015 be extended to November 2, 2015.

Further, Veolia was directed to respond to CTG’s First Amended Formal Complaint (“Complaint) or request mediation no later than October 22, 2015. Veolia seeks an Order extending the time to respond to the Complaint or request mediation by fourteen (14) days, up to and including November 5, 2015.

This motion is not filed for the purpose of delay or harassment, but rather to allow the parties additional time to explore resolution of this dispute.

The parties discussed this request with Staff Counsel, and Staff Counsel does not oppose this request.
