On February 29, 2012, the Missouri Public Service Commission (Commission), issued its Report and Order (Order) in Case No. GM-2011-0412, directing Missouri Gas Energy (MGE or Company) to accomplish all necessary and appropriate purposes to consummate the transaction and related undertakings in accordance with the merger agreement. This Order included approval of the Non-Unaminous Stipulation and Agreement (Stipulation) filed in the case.

On March 12, 2012, MGE filed P.S.C No. 1 Fourth Revised Sheet 16 in response to the Commission's Order approving the Stipulation. The tariff sheet describes costs MGE is permitted to recover in the Purchased Gas Adjustment (PGA) or Actual Cost Adjustment (ACA). The tariff also lists costs MGE is not permitted to recover in the PGA or ACA, which are related to charges for performance, or surety bonds or letters of credit that have been required by commodity suppliers as a result of this merger transaction in Case No. GM-2011-0412.

On March 12, 2012, the Commission issued an ORDER DIRECTING RECOMMENDATION REGARDING TARIFF. This recommendation is in response to the March 12, 2012 Order.

The Commission's Energy Unit - Tariff/Rate Design Staff (Staff) has reviewed the tariff sheet filed by MGE on March 12, 2012, and is of the opinion that this sheet is in compliance with the Commission's Order.
