5. In the attached *Memorandum*, the Staff states it has reviewed the compliance tariff sheets as filed by Veolia on September 29, 2011, and accepted as compliance tariffs by the Commission on October 13, 2011, and such tariffs are the specimen tariffs filed as Appendix A to the September 29, 2011 *Agreement*. Therefore, the Staff recommends the Commission approve the following tariff sheets filed on October 17, 2011, and allow them go into effect on the requested effective date of November 1, 2011.

WHEREFORE, the Staff respectfully submits this *Recommendation* for the Commission's information and consideration, and recommends that the Commission approve the compliance tariffs for an effective date of November 1, 2011.

SUBJECT: Staff Recommendation On Veolia Energy Kansas City, Inc.'s Tariff Sheets Filed to Comply with the Commission's Order Approving Stipulation and Agreement

DATE: October 26, 2011

On September 29, 2011, Veolia Energy Kansas City, Inc. (Veolia or Company) filed, along with the signatory parties, a Stipulation and Agreement (Agreement). Attached to the Agreement were specimen tariff sheets designed to incorporate the agreed upon provisions of the signatories.

On October 12, 2011, the Missouri Public Service Commission (Commission) issued its Order Approving Stipulation and Agreement (Agreement Order) in Case No. HR-2011-0241, Veolia's steam heating rate case. This Order approved an increase in the Company's overall Missouri jurisdictional gross annual **steam heating** revenues of approximately \$1.4 million. The Order directed Veolia to file a new tariff consistent with the Agreement. The Order also directed Staff to file a recommendation on the compliance tariff by October 26, 2011.

On October 12, 2011, Veolia filed a Motion for Acceptance of Settlement Tariffs as Compliance Tariffs (Motion). The Motion asked that the Commission accept the tariff sheets included in Attachment A of the Agreement as its compliance tariff filing. Veolia also requested that these tariff sheets be entered in the Commission's electronic filing system.

On October 13, 2011, the Commission issued its Order Filing Settlement as Compliance Tariff (Order). The Order granted Veolia's Motion and found the tariff sheets attached to the Agreement to be filed in compliance with the Commission's October 12, 2011 Agreement Order.

The Commission's Data Center filed the compliance tariff sheets pursuant to the Commission's Order and opened a new file, File No. HR-2012-0118.

The Commission's Energy Department - Tariffs/Rate Design Staff (Staff) has reviewed the tariff sheets as filed by the Commission's Data Center on October 17, 2011, and is of the opinion that these sheets are identical to the tariff sheets identified as Appendix A to the Commission approved Agreement. Therefore, Staff recommends the following tariff sheets filed on October 17, 2011 be approved and allowed to go into effect on the requested effective date of November 1, 2011:
