**ORDER DIRECTING FILING REGARDING CLARIFICATION  
OF TARIFF STATUS**

On December 9, 2016, Laclede Gas Company (“Laclede”) and Missouri Gas Energy (“MGE”) filed responses to Staff’s recommendations. The responses filed by Laclede and MGE made reference to attached tariff sheets as “specimen tariff sheets”, but those attached tariff sheets both stated effective dates of January 8, 2017. This inconsistency between the language in the responses and the inclusion of tariff effective dates could cause confusion about whether Laclede and MGE intend those attached tariff sheets to go into effect. The Commission will direct Laclede and MGE to file a notice clarifying whether the tariff sheets attached to the responses are intended to go into effect on January 8, 2017.

**THE COMMISSION ORDERS THAT:**

1. Laclede Gas Company and Missouri Gas Energy shall file a notice as described in the body of this order no later than December 14, 2016.

2. This order shall be effective when issued.


