On January 30, 2012, Missouri Gas Energy (MGE or Company), a division of Southern Union Company, of Kansas City, Missouri, filed a tariff sheet bearing an effective date of February 13, 2012. This tariff sheet was filed to reflect a change in MGE's Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas for the remaining 2012 winter season.

This filing will decrease the firm PGA factor for the remaining 2012 winter season to \$0.52744 per one-hundred cubic feet (Ccf), from the current PGA factor of \$0.61559 per Ccf. This represents a decrease of \$0.08815 per Ccf.

Case No. GR-2012-0262, under which these changes were filed, was established to track the Company's PGA factors to be reviewed in its 2011-2012 Actual Cost Adjustment (ACA) filing. Case No. GR-2011-0290 was established to track the Company's PGA factors to be reviewed in its 2010-2011 ACA filing. Case No. GR-2010-0372 was established to track the Company's PGA factors to be reviewed in its 2009-2010 ACA filing. This rate change should be on an interim, subject to refund status pending final Commission decisions in ACA Case Nos. GR 2012-0262, GR-2011-0290, and GR-2010-0372.

Staff is of the opinion that good cause for approval of this tariff sheet on less than thirty (30) days notice is demonstrated by MGE's Commission-approved PGA Clause allowing for ten (10) business days notice for PGA change filings. Staff has verified that this company has filed its annual report and is not delinquent on any of its assessment. Staff is not aware of any other matter before the Commission that affects or is affected by this filing.

Although MGE filed its tariff sheet with a requested effective date of February 13, 2012, the Commission may approve it and order an earlier effective date. Staff recommends that the filing be approved to become effective on February 13, 2012, and that the following tariff sheet, filed on January 30, 2012, be approved, interim subject to refund:
