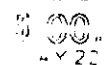

**ORDER DIRECTING FILING**

On February 1, 2007, Kansas City Power & Light Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for electrical service provided in its Missouri service area. The Commission issued an Order and Notice on February 6 that required, among other things, the Office of the Public Counsel to submit a proposed local public hearing places and dates, and a proposed customer notice, no later than March 28.

OPC timely filed its preference for dates and places of local public hearings, but has yet to file a proposed customer notice. Now that the Commission is attempting to arrange local public hearings, the Commission will again order OPC to submit a proposed customer notice, and will allow parties a chance to respond to that notice.

**IT IS ORDERED THAT:**

1. The Office of the Public Counsel shall submit a proposed customer notice no later than June 1, 2007.
2. Any party wishing to respond to the above ordered notice shall do so no later than June 8, 2007.

3. This order shall become effective on May 22, 2007.
