## NOTICE OF CONTESTED CASE AND ORDER DIRECTING FILING

Issue Date: January 10, 2011 Effective Date: January 10, 2011

The Commission is giving notice that a contested case has begun and directing filings. On January 10, 2011, the complainant filed the complaint, a copy of which accompanies this notice. Such filing vested the right to a pre-decision evidentiary hearing in the respondent, 1 so that filing instituted a contested case. 2

A contested case is a formal hearing procedure, but it allows for waiver of procedural formalities and a decision without a hearing,3 including by stipulation and agreement.4 As an alternative to the formal evidentiary hearing procedure, the Commission offers mediation. Mediation is a voluntary process in which a neutral person assists the parties in exploring opportunities for settlement. Upon a request for mediation, the Commission may suspend the filing date set forth in this order.

Provisions governing discovery are at the Commission's regulation 4 CSR 240-2.090. The Commission's regulations<sup>5</sup> require the filing of an answer not later than February 9, 2011.

The Commission will also set a filing date for Staff's report on the complaint.

## THE COMMISSION ORDERS THAT:

- 1. The answer shall be filed no later than February 9, 2011.
- 2. The Commission's staff shall file its report no later than February 16, 2011.
- 3. This order shall be effective immediately on issuance.
