MOTION TO CORRECT REPORT AND ORDER NUNC PRO TUNC

COMES NOW KCP&L Greater Missouri Operations Company (“GMO” or the
“Company”) and states as follows:

1. On March 2, 2016, the Commission issued its Report and Order in the above-captioned proceeding, to be effective on March 12, 2016.

2. The Report and Order contains the following requirement f) on p. 19:

f) File with the Commission an evaluation of the Plan required by e) after the Greenwood Solar Facility has operated for a period of five years before the company’s application for a certificate of convenience and necessity for its next utility-scale solar facility.

3. The Company believes that condition f) is missing the word “or” between the words “years” and “before”. The addition of the word “or” would make this condition consistent with Staff’s condition 6 contained in Staff’s February 8, 2016 position statement. Condition 6 reads:

6) GMO will file with the Commission an evaluation of its Plan required by Condition 5 after the Greenwood Solar Facility has operated for a period of 5 years or prior to GMO’s application for a CCN for its next utility-scale solar facility.

4. The corrected requirement would read:

f) File with the Commission an evaluation of the Plan required by e) after the Greenwood Solar Facility has operated for a period of five years

or before the company's application for a certificate of convenience and necessity for its next utility-scale solar facility.

5. With the addition of the word "or" to requirement f), the requirement is acceptable to the Company. The Company requests that the Commission correct its Report and Order as promptly as possible.

WHEREFORE, the Company respectfully requests that the Commission issue its order correcting requirement f) in the Report and Order as indicated herein.
