**JOINT STATUS REPORT**

**COMES NOW** Summit Natural Gas of Missouri, Inc. (“Summit Natural Gas” or “Company”), the Staff of the Missouri Public Service Commission (“Staff”), and the Office of the Public Counsel (“Public Counsel”), and jointly state as follows:

1. On May 24, 2012, the Commission issued its *Order Granting Joint Request Regarding Continuing Discussions*, approving Summit Natural Gas’ request that the parties file monthly status reports until Summit Natural Gas files a Cost Allocation Manual (“CAM”) acceptable to all parties, or until the parties notify the Commission that they are unable to reach an agreement. The Commission ordered the parties to file a monthly status report on the last working day of the month until otherwise ordered.

2. Summit Natural Gas filed its application in this case on March 28, 2012. Staff has reviewed the Company’s responses to data requests, and Staff will continue to review the CAM filed in this case in relation to other cost allocation manuals filed in other cases<sup>1</sup> and will seek additional information from Summit Natural Gas, as needed.

**WHEREFORE**, the signatory parties submit their *Joint Status Report*.

Staff has recently provided the parties a new draft of proposed language for Empire’s Cost Allocation Manual, taking into account some of the content of Laclede Gas Company’s Cost Allocation Manual that was recently approved by the Commission in Case No. GC-2011-0098. In that case, the parties reached agreement and the Commission issued its *Order Dismissing Complaint and Counterclaims with Prejudice* on August 26, 2013.
