**STAFF'S NOVEMBER 30, 2017 STATUS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through undersigned Staff counsel, and states as follows for the *Staff's November 30, 2017, Status Report*:

1. The Staff previously reported that a conference call / meeting was scheduled for Thursday, November 16, 2017, 10:00 a.m., Conference Room 110, Governor Office Building, Jefferson City, Mo. for Summit Natural Gas of Missouri, Inc. ("SNG"), the Staff, and Office of the Public Counsel ("Public Counsel") to discuss SNG's CAM proposal, the Staff's "redlined" version of SNG's CAM proposal including Staff's questions and comments, and any questions and comments the Office of the Public Counsel ("Public Counsel") might have.

2. The week prior to the scheduled conference call / meeting was to occur SNG apprised the Staff that SNG's controller had recently taken employment outside the Summit Utilities Inc., system and a new controller was in the process of familiarizing herself with what had occurred previously respecting the SNG proposed CAM and the Staff's September 29, 2017, redlined version response, including questions and comments. There was a question of whether the scheduled November 16 meeting should occur as scheduled, and the Staff recommended that it should.

3. The November 16, 2017, conference call / meeting occurred as scheduled involving SNG, the Staff and Public Counsel. When the conference call / meeting concluded it was left to SNG to get back with the Staff and Public Counsel to suggest the next step and the timing.

4. The Staff has heard back from counsel for SNG in the last day and he advises that SNG plans to have a further draft back to Staff and Public Counsel by the end of December.

**WHEREFORE**, the Staff submits its *November 30, 2017, Status Report*.
