ORDER SHORTENING TIME FOR REPLIES

On December 22, 2021, Spire Missouri Inc. d/b/a Spire submitted an application requesting financing authorization in the amount of \$800 million through December 2024, subject to all of the terms and conditions approved by the Commission in File No. GF-2020-0334.

On February 10, 2022, the Office of the Public Counsel (OPC) suggested an additional three conditions or modifications to Staff's suggested conditions. Spire was directed to respond and other parties were allowed to respond if they wish. Spire responded as follows:

- suggested typographical corrections to Staff Condition 1;
- edits discussed by Spire and OPC to Staff Condition 7;
- accepts OPC's 2nd proposed condition;
- offered language addressing OPC's third proposed condition.

Spire has requested expedited treatment of this file such that it desires a Commission decision before March 1, 2022. The Commission will therefore shorten the time for replies to Spire's filing.

THE COMMISSION ORDERS THAT:

1. Any party that wishes to reply to Spire's filing of February 17, 2022, shall file such response on or before 12:00 p.m. (noon) February 22, 2022.
2. This order shall be effective when issued.
