## **STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEET**

1. In the attached Memorandum (Appendix A) the Staff recommends the Commission approve the tariff sheet KCP&L Greater Missouri Operations Company (GMO) filed on June 9, 2011, to become effective July 9, 2011.

2. This tariff sheet addresses a typographical error contained on GMO's P.S.C. MO. No. 1 7<sup>th</sup> Revised Sheet No. 6.10 Canceling 6<sup>th</sup> Revised Sheet No. 6.10, which became effective June 1, 2011.

3. The "Last Effective Date" of the Quarterly Cost Adjustment (QCA) for the first quarter of 2011 was given as 5/31/2011 on the 7<sup>th</sup> Revised Sheet No. 6.10. Instead, that date should read 5/31/2012, as it does on the 8<sup>th</sup> Revised Sheet No. 6.10, Tariff Tracking No. YH-2011-0622.
