## KCP&L GREATER MISSOURI OPERATIONS COMPANY'S MOTION FOR EXTENSION OF TIME

COMES NOW, KCP&L Greater Missouri Operations Company ("GMO" or "Company") and hereby requests the Commission grant an extension until April 15, 2013 to file its new Quarterly Cost Adjustment ("QCA") Tariff. In support of its motion, GMO states:

- 1. On February 27, 2013 the Missouri Public Service Commission ("Commission") issued its *Order Regarding Remand* in the above-captioned matters, with a March 5, 2013 effective date. GMO was ordered to file a new QCA Tariff within twenty (20) days of the effective date of the *Order Regarding Remand*.
- 2. GMO hereby requests the Commission grant its extension request from March 25, 2013 to April 15, 2013 for the following reasons:
  - a. Pursuant to the Non-Unanimous Stipulation and Agreement in Case No. HR-2005-0450 and the Stipulation and Agreement in Case No. HR-2009-0092, GMO

prepares and files a routine QCA Tariff filing quarterly no later than January 15,

April 15, July 15, or October 15. Therefore, GMO will be filing its next quarterly

filing on April 15, 2013, with a tariff effective date of June 1, 2013.

b. If GMO is permitted to submit its new QCA Tariff ordered in the above-captioned

dockets on April 15, 2013, it will coincide with the routine filing referenced in

subparagraph a above.

c. If GMO is not permitted the requested extension, two versions of the same tariff

will need to be filed prior to the effective date of either tariff. One tariff would be

filed on March 25, 2013 to comply with the Order Regarding Remand and one

tariff would be filed no later than April 15, 2013 with the January through March

fuel cost information not available by the March 25, 2013 ordered filing date.

d. The recovery will be made within the mechanism that has already been in place

since 2006. This mechanism is understood by the Commission, MPSC Staff and

the affected steam customers.

WHEREFORE, GMO respectfully requests that the Commission grant its extension

request from March 25, 2013 to April 15, 2013 to file its new QCA Tariff.
