## SECOND ORDER GRANTING MOTION FOR EXTENSION OF TIME

On December 12, 2016, the Commission issued an *Order Granting Motion for Extension of Time*, which established a deadline of January 6, 2017 for Laclede Gas Company to respond to Staff's Gas Incident Report or, in the alternative, file a status report. On January 6, 2017, Laclede filed a status report indicating that it is close to reaching an agreement with Staff and requesting an extension of time until January 31, 2017 to file its response. Laclede represents that Staff does not object to the request. The Commission finds the request reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Laclede Gas Company's request for an extension of time filed on January 6, 2017, is granted.
2. The deadline for Laclede Gas Company to file a response to Staff's Gas Incident Report, or in the alternative a status report on the progress of discussions with Staff, is extended until no later than January 31, 2017.

3. This order shall be effective when issued.
