STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and in response to the Commission's *Order Directing Staff to Continue Investigation* (Order), states as follows:

1. On February 27, 2013, the Commission issued its *Order Opening File and Directing Filing* which directed Staff to investigate the natural gas incident which occurred on February 19, 2013, at JJ's Restaurant at 910 West 48th Street, Kansas City, Missouri, and to file interim progress reports on March 27, April 24, and May 29, 2013, and either a Gas Incident Report or a Status Report no later than June 27, 2013. On June 26, July 31, September 4, 2013, October 3, 2013, and November 6, 2013, the Commission issued Orders directing Staff to continue to investigate the incident and to file Status Reports no later than July 26, August 27, September 27, October 28, and December 31, 2013 respectively.

2. Staff began its investigation into the natural gas explosion and fire at JJ's Restaurant on February 19, 2013, the day of the incident. Staff's investigation activities have continued since the night of February 19th and its investigation is ongoing.

3. The area surrounding the incident site has been secured from the time the site was released by the Kansas City Fire Department on February 20, 2013. Access to the site was blocked by fencing, a construction barrier wall, and locked gates until the final on-site investigations were conducted on July 8 and 9, 2013.

4. Staff's on-site investigation and gathering of information have now been completed. Missouri Gas Energy (MGE) has provided Staff its finalized responses and answers in narrative format to Staff's information requests and to an additional information request. MGE's answers include a substantial number of supporting documents, including pertinent cell phone records, GPS locational records, and other detailed documents and data supporting its answers. Other parties have also provided Staff with responses and answers to Staff's information requests.

5. Staff has been working on the Gas Incident Report since completion of its investigation and gathering of information. At this time, Staff anticipates the Gas Incident Report should be filed on or before February 6, 2014. The completed Gas Incident Report will explain in detail the facts surrounding the February 19, 2013 Incident, as well as Staff's analysis, conclusions and recommendations. The focus of Staff's investigation and its resulting Gas Incident Report is to determine whether Missouri Gas Energy was in compliance with applicable Commission regulations, and any applicable State and Federal safety standards.

WHEREFORE, Staff prays the Commission will accept its Status Report pursuant to the Commission's Order and allow Staff to continue preparing its Report with an anticipated filing of its Gas Incident Report on or before February 6, 2014.
