APPLICATION FOR A CONTINUANCE

Comes Turkey Mountain Estates Home Owners Association Nos. 1 and 2 by their attorneys of record, Fain & Fain, 333 Madison Street, Jefferson City, Missouri, and for continuance states:

Turkey Mountain Estates Home Owners Association Nos. 1 and 2 are made up of property and home owners in the area attempting to be certified by the Applicant. Both associations are contesting the right of the Applicant to act as a public utility to sell water to the members of these associations.

In order for them to properly put on their evidence, it will be necessary for a large number of the homeowners to be present and put on their evidence, especially as to the ownership of the water lines in question.

It is estimated that at least one or two days will be taken in further cross-examination of the Applicant's witnesses. Also a factor is the long range forecast predicting snow for the coming weekend, which is likely to make it impractical for the intervenors to travel to Jefferson City next Wednesday and Thursday. Furthermore, it will be very difficult and expensive for them to stand by until they are able to present their case.

The undersigned has endeavored to reach some agreement with Applicant's attorney, but has been informed he will not be back in the office until sometime next week.

Intervenors ask that this matter be continued to a date to be fixed, or in the alternative that Applicant's witnesses be heard beginning January 11, 1979, and that the intervenors be given a date certain when they can be heard for their portion

of the case and for issuance of subpoenas duces tecum to witness Roger Taylor as follows:

All original records of any monies expended in the development and operation of the water facilities which are the subject of the application in Case No. W-A-78170; copies of all federal income tax records filed by the developers from the beginning of development of the lots which expensed any costs of items pertaining to the water facilities.
