- JUDGE STEARLEY: We are on the record in
- 4 File Number GR-2010-0192. Today is Wednesday July
- 5 the 7th, and we are in Caruthersville, Missouri
- 6 having a listening post. We're allowing the public
- 7 to come in and make statements regarding the Atmos
- 8 rate case.
- 9 EXAMINATION
- 10 OUESTIONS BY JUDGE STEARLEY:
- 11 Q. And, sir, if you would, please state and
- 12 spell your name for our court reporter.
- 13 A. My name's Joe Robinson, J-O-E,
- 14 R-O-B-I-N-S-O-N. I live in Malden. Atmos supplies
- 15 us.
- 16 Q. All right. And are you a customer of
- 17 Atmos?
- 18 A. I said Atmos supplies us.
- 19 Q. Okay. Go ahead and give us your statement.
- 20 A. Oh, just a general statement that in these
- 21 time of economy and all people is getting down to
- 22 where they is survival time, you know. They can't
- 23 pay bills and all, and they're just existing. And I
- 24 know a few of them people and all, and I know also
- 25 that like our government they're taking money and

- 1 transferring wealth and all. And I know sometimes
- 2 Atmos and other companies does it too, which I'm not
