## ORDER MODIFYING TIME FOR DATA REQUESTS

Staff's filed its motion to modify the times to comply with or object to data requests ("motion").<sup>1</sup> Spire, Inc., ("Spire") filed a response<sup>2</sup> and an amended response.<sup>3</sup> The time to answer or object to data requests is subject to agreement or the Commission's order.<sup>4</sup> Spire and Staff agree to the shortened times as ordered. Spire asks that the Commission deem all data requests already served to have been served on the effective date of this order. The Commission will grant those requests.

### THE COMMISSION ORDERS THAT:

1. The *Staff's Motion to Shorten Time to Respond and Object to Data Requests and Motion for Expedited Treatment* is granted.
2. The time to comply with data requests shall be eight business days.
3. The time to object to data requests shall be five business days.


