1 P R O C E E D I N G S

2 JUDGE STEARLEY: All right. Good evening.
3 It's Wednesday, July 7, 2010. The Missouri Public Service
4 Commission has set this time for the public hearing, File
5 No. GR-2010-0192, in which Atmos Energy Corporation seeks
6 to implement a general rate increase for the natural gas
7 service it provides for the state of Missouri.

8 Commissioner Davis is in attendance in the
9 audience. However, I'm afraid we have no members of the
10 public or representatives of the parties. Nonetheless,
11 I'm going to make a brief record, and we'll have Counsel
12 enter their appearance starting with Atmos Energy.

13 MR. DORITY: Thank you, Judge.

16 I've provided the reporter with a written entry of

18 JUDGE STEARLEY: Thank you, Mr. Dority.
19 With the Office of the Public Counsel.

20 MR. POSTON: Marc Poston with the Office of
21 the Public Counsel and Public Commission.

22 JUDGE STEARLEY: Okay. For the staff of
23 the Missouri Public Service Commission.

24 MR. DEARMONT: Thank you, Judge. Eric
25 Dearmont on behalf of the staff of the Public Service

1 Commission. P.O. Box 360, Jefferson City, Missouri,
2 65102.

3 JUDGE STEARLEY: Thank you, Mr. Dearmont.
4 We'll let the record reflect that none of the intervenors
5 have entered an appearance through counsel this evening.
6 As I have noted, we have no members from the public that
7 showed up tonight, so the record will be brief.

8 Mr. Davis, would you like to make any
9 remarks at all?

10 COMMISSIONER DAVIS: No.

11 JUDGE STEARLEY: Thank you very much,
12 Commissioner. Since no one is here to provide testimony
13 -- we do want to thank our host here in Hayti for allowing
14 us to use their facilities. Since no one is here we can
15 go ahead and rapidly conclude our public hearing in File
16 No. GR-2010-0192. It is hereby adjourned. Thank you very
17 much.
