On October 26, 2016, Summit Natural Gas of Missouri, Inc. filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment clause. The tariff sheets bear an effective date of November 9, 2016.

THE COMMISSION ORDERS THAT:

1. No later than October 31, 2016, the Staff of the Missouri Public Service Commission shall file a recommendation with regard to the tariff sheets filed by Summit Natural Gas of Missouri, Inc.

2. This order shall be effective when issued.


