After receiving a *Motion for Clarification* from Spire Missouri Inc. d/b/a Spire (Spire Missouri) and responses to that motion from the Office of the Public Counsel (OPC) and the Staff of the Commission (Staff), the Commission issued an *Order Providing Clarification to Report and Order and Delegating Authority* on November 3, 2021.
