On December 11, 2020, Spire filed tariff sheets to adjust its retail rates and other tariff provisions for both its Spire East and Spire West operating units with an effective date of January 10, 2021. The Commission suspended those tariff sheets, filed under Tariff Tracking No. YG-2021-0133, on December 30, 2020 until November 10, 2021.

Various parties to the case filed a Non-Unanimous Stipulation and Agreement on July 23, 2021, a Partial Stipulation and Agreement on July 30, 2021, a Non-Unanimous Stipulation and Agreement on August 5, 2021, a Partial Stipulation and Agreement on August 12, 2021, and a Motion to Amend [the July 30, 2021] Partial Stipulation and Agreement on September 8, 2021. A hearing on the remaining issues was held on August 2-6, 2021.

On September 15, 2021, the Commission issued its *Order Approving Partial Stipulation and Agreements*. On October 27, 2021, the Commission issued its *Report and Order* which, among other provisions, rejected the tariff sheets filed under Tariff Tracking No. YG-2021-0133. On November 3, 2021, the Commission issued its *Order Providing Clarification to Report and Order and Delegating Authority* and further amended the *Report and Order* on November 12, 2021 with its *Amended Report and Order*.

Spire filed tariff sheets in Tariff Tracking No. YG-2022-0151 on November 10, 2021, and substitute tariff sheets on November 17, 2021. Spire withdrew the tariffs filed in Tariff Tracking No. YG-2022-0151 on November 23, 2021, and filed a Replacement Tariff on November 23, 2021 under Tariff Tracking No. YG-2022-0162 to comply with the Commission's *Amended Report and Order*. Spire further substituted the tariff sheets in Tariff Tracking No. YG-2022-0162 on December 9, 2021, and noted in its accompanying transmittal letter that the substitutes being filed reflected input Spire received from Staff and other Parties.
