On November 11, 2022, Spire Missouri, Inc. d/b/a Spire filed revised tariff sheets to reflect changes in its Purchased Gas Adjustment for its eastern Missouri and western Missouri operating divisions. The tariff sheets bear an effective date of November 29, 2022.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any responses to the tariff sheets.

2. Any other comments or recommendations concerning Spire's tariff sheets shall be filed no later than November 21, 2022.
