Comes now Paper, Allied-Industrial, Chemical and Energy Workers Local 5-6, AFL-CIO ("PACE Local 5-6"), an intervenor here, pursuant to 4 CSR 240-2.115, and in response to Second Amended Stipulation and Agreement filed on September 5, 2002, states as follows:

1. On September 5, 2002, Laclede Gas Company, the Missouri Public Service Commission Staff, the Office of the Public Counsel, the Missouri Industrial Energy Consumers, and the Missouri Energy Group entered into a Second Amended Stipulation and Agreement (the "Agreement"). The Agreement resolves issues involved in this case.

2. In response to the Agreement, PACE Local 5-6 states that it neither supports nor opposes the terms of the Agreement. Further, PACE Local 5-6 waives its right to a hearing on the matters specifically covered by the Agreement.
