**NOTICE OF ELECTION OF WAIVER OF
COMMISSION RULES AND STATUTES**

COMES NOW, Grand River Mutual Telephone Company ("Company") pursuant to Sections 392.420 and 392.461 RSMo. and notifies the Missouri Public Service Commission ("Commission") of its election to waive and be exempt from the application and enforcement of certain commission rules and statutes.

1. Company is a Missouri corporation duly authorized to conduct business in the state of Missouri, with its principal office located at 1001 Kentucky Street, Princeton, MO 64673. Copies of Company's Certificate of Good Standing from the Missouri Secretary of State were filed in Case No. TC-2011-0404, and are incorporated by reference herein. Company is a "local exchange telecommunications company" and a "public utility" and is duly authorized to provide "telecommunications service" within the state of Missouri as each of those terms is defined in Section 386.020 RSMo.

3. Company has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court that involve Missouri retail customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Notification. No Missouri annual reports or assessment fees are overdue.

4. In Case No. TE-2011-0159, Company previously waived some, but not all, of the rules and statutes allowed to be waived after the passage of H.B. 1779 in 2008.

5. At that time, one or more alternative local exchange carriers and/or interconnected voice over Internet protocol (VoIP) providers were authorized or registered to provide service in the Company's authorized service area, and the same is true today.

6. Staff has opened this Case File TE-2012-0073 to allow telecommunications companies to file notifications of elections of waivers exercised pursuant to Sections 392.420 and 392.461, as amended by HB 338.

9. In accordance with Sections 392.420 and 392.461, as amended by HB 338, the Company hereby exercises its statutory right to elect to waive the application and enforcement of the following statutes and rules (which are identical to those listed in Paragraph 4 of the Motion of the Staff of the Missouri Public Service Commission filed October 18, 2011 in this File):

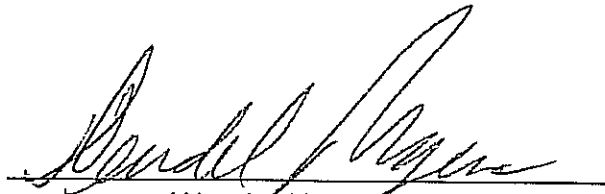

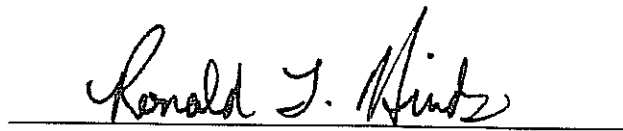
