ORDER DIRECTING STAFF RECOMMENDATION

On August 25, 2021, Liberty Utilities (Midstates Natural Gas) Corp. (Liberty-Midstates) applied for an accounting authority order permitting it to track and defer in a regulatory asset beginning February 2021, all incremental costs, and other financial impacts of Winter Storm Uri. The Commission will direct its Staff to file a recommendation regarding that application.

THE COMMISSION ORDERS THAT:

1. Staff shall file either a recommendation regarding Liberty-Midstates' application for accounting authority order, or a pleading indicating when it will be able to file such a recommendation, no later than October 28, 2021.
2. This order shall be effective when issued.
