SBC MISSOURI'S RESPONSE TO OPC'S MOTION TO REJECT TARIFF

SBC Missouri¹ respectfully opposes Office of the Public Counsel's ("OPC's") March 3, 2003 Motion to Reject Tariff, or in the Alternative, to Suspend.

OPC misunderstands SBC Missouri proposed tariff change. OPC mistakenly claims that:

This tariff does not afford the ratepayer adequate protection from billing errors and is not in the public interest because it places an undue obligation on the customer to pay late charges on the disputed charges on the residential and business customers bill.²

OPC has it just the opposite. The proposed tariff allows SBC to exempt the disputed charge from the late payment charge until the dispute is resolved. Currently, the tariff language states: "When the balance carried over is in dispute, the Late Payment Charge will be applied and adjusted later, if appropriate, based on the resolution of the claim." The proposed tariff changes the word "will" to "may" and adds another short paragraph explaining SBC's intent to give SBC the ability to exempt such charges when a customer calls in to acquire about his or her bill: "Where possible, the Company will exempt the disputed portion of the bill from Late Payment Charges until the claim is resolved. If the claim is resolved in favor of the Company,

the Late Payment Charge will be applied if appropriate." SBC does not propose any other change in how it handles billing disputes.

SBC Missouri proposes this change to benefit customers and respectfully requests the Commission to allow it to go into effect as filed.
