I am writing in regard to the COS and Internet issues. As I gathered at a November 12 meeting on COS (sponsored by Senator Mathewson and held in Marshall), telephone companies are required to offer COS and they generally lose money doing so. While the service is a useful one to many rural residents, I don't think the companies should have to provide the service below cost.

However, many rural residents have become dependent on a low-cost COS, and it would be a hardship on these people to discontinue the service with no alternative. As I understand it, two-way toll-free calling (as provided by COS) is not feasible in the new competitive environment. But for those on the Internet, worldwide two-way toll-free calling is now a reality. The cost of the equipment necessary to access the Internet is falling, and the necessity to have Internet access is increasing. Therefore, I suggest that part of the solution to the COS problem is to ensure that all citizens have toll-free access to the Internet before discontinuing COS.




