## SPIRE MISSOURI INC.'S MOTION FOR EXTENSION

**COMES NOW** Spire Missouri Inc. ("Spire Missouri"), and, as its *Motion for Extension*, respectfully states as follows to the Missouri Public Service Commission ("Commission"):

1. On February 17, 2022, the Commission issued its *Order Granting Symmetry's Motion to Compel Production of Responsive Documents* ("Order"). The Order directed certain responses to be provided by February 17, 2022, at 5 pm; additional specified responses to be provided by February 18, 2022; and provided generally for any other responsive documents to be provided by March 3, 2022.

2. The Commission previously modified the procedural schedule, at the request of the parties, to provide for a settlement conference. That settlement conference is taking place February 17-18, 2022. The parties participated in that proceeding yesterday. However, it was necessary for Spire Missouri to break in order to address the February 17, 2022 items identified by the Order.

3. In order to provide the opportunity for Spire Missouri to participate in the settlement conference today without interruption, Spire Missouri requests an extension of the February 18, 2022 deadline until February 21, 2022.

4. Spire Missouri has discussed this matter with counsel for Symmetry Energy

Solutions, LLC and he has stated that Symmetry supports this motion. Counsel for the Staff of the Commission, Office of the Public Counsel, Midwest Energy Consumers Group and the Missouri School Boards' Association have indicated they have no objection.

**WHEREFORE**, Spire Missouri respectfully requests that the Commission grant the Motion for Extension as described herein.
