KCP&L GREATER MISSOURI OPERATIONS COMPANY'S MOTION TO CORRECT TARIFFS AND REQUEST FOR EXPEDITED TREATMENT

COMES NOW KCP&L Greater Missouri Operations Company ("GMO" or the "Company") and, for their *Motion to Correct Tariffs and Request for Expedited Treatment* ("Motion"), state as follows:

1. On November 29, 2018, GMO submitted its revised tariffs (Tracking No. YE-2019-0105) relating to its MEEIA 3 programs ("GMO MEEIA 3 Tariffs"). The MEEIA 3 cases are still ongoing and the MEEIA 2 programs were extended though this Commission's approval of a Stipulation¹, and the GMO MEEIA 3 Tariffs submitted on November 29th have not been approved by the Missouri Public Service Commission ("Commission"). Nevertheless, several GMO MEEIA 3 Tariffs are shown as currently effective in EFIS.

On May 30, 2019, GMO submitted a motion to address only tariff sheet 138.7, which contains rates needed for GMO's DSIM rider filing which was due to be filed on May 31, 2019.

3. The Missouri Public Service Commission ("Commission") issued its *Order Granting Motion to Correct Tariff and Request for Expedited Treatment* on June 5, 2019 with an effective date of June 15, 2019 (June 5th Order).

4. This pleading seeks correction of the remaining GMO MEEIA 3 Tariffs, similarly to the single sheet correction the Commission approved with its June 5th Order.

5. Simultaneously with this Motion, the Company files the corrected tariff sheets ("Corrected Tariff Sheets"). The Company requests expedited treatment of Corrected Tariff Sheets so that they become effective as soon as is practical for the Commission. The Corrected Tariff Sheets replacing the currently effective GMO MEEIA 3 Tariffs are exactly the same as the previously effective tariff sheets in place for each individual tariff sheet prior to the GMO MEEIA 3 Tariffs being erroneously made effective. For details of prior relevant Tracking Nos. and Issue/Effective Dates being reverted to, please see the attached **Exhibit A**.

6. There will be no negative effect on the Company's customers or the general public if the Commission grants this Motion.

7. This Motion was filed as soon as it could have been under the circumstances.

WHEREFORE, for the foregoing reasons and for good cause shown, GMO respectfully requests the Commission grants this Motion with expedited consideration.
