ORDER APPROVING EXPEDITED TARIFF

Effective Date: April 27, 2011

On April 11, 2011¹, Atmos Energy Corporation ("Atmos") filed revised tariff sheets that would implement "Energize Atmos Energy Homes". Atmos states that it filed the tariff sheets in accordance with the Commission's Order Approving Stipulation and Agreement in File No. GR-2010-0192.

The tariff sheets bear an effective date of May 12. But Atmos filed a motion along with its tariff asking the Commission to approve the tariff sheets during the Commission's April 27 Agenda meeting. Atmos also states that it is authorized to state that the Commission's Staff, the Office of the Public Counsel, and the Missouri Department of Natural Resources do not object to the requested relief.

The Commission's Staff filed an expedited recommendation regarding the proposed tariff on April 18, and an amended recommendation on April 20. Staff recommends the Commission grant Atmos' request for expedited treatment and approve the tariff sheets with an effective date of April 27.

Based on the recommendation of its Staff, and Atmos' representation that no party objects, the Commission will approve the submitted tariff on an expedited basis.
