On September 10, 2015, the Staff of the Commission filed a Motion to Continue Ameren Missouri Progress Reports ("motion"). The motion states that compliance with Staff's recommendations is taking longer than expected, and that the Commission should continue to order Ameren Missouri to file quarterly progress reports. No party objects to Staff's motion.

The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri shall file quarterly progress reports regarding implementing Staff's recommendations on the first business day of October, January, April, and July until otherwise ordered by the Commission.
2. This order shall be effective when issued.


