- 1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission (Commission) grant approval of the Interconnection Agreement Amendment between Southwestern Bell Telephone Company d/b/a AT&T Missouri (AT&T) and XO Communications Services, Inc. filed by AT&T under the provisions of the federal Telecommunications Act of 1996.
- 2. The terms of the amendment to the Agreement do not discriminate against telecommunications carriers not a party to the Agreement and are not against the public interest, convenience or necessity. Pursuant to 47 U.S.C. §252(e), the Commission is to approve an amendment to a negotiated interconnection agreement unless the terms of the amendment discriminate against a telecommunications carrier not a party to the agreement, or implementation of the amendment to the agreement is inconsistent with the public interest, convenience, or necessity.

WHEREFORE, because the terms of the amendment to the agreement satisfy the standard set forth in 47 U.S.C. §252(e), Staff recommends the Commission approve the

amendment and direct the parties to submit any future modifications or amendments to the Interconnection Agreement to the Commission for approval.
