On May 31, 2016<sup>1</sup>, the Staff of the Commission filed a monthly status report and an additional request. That request is for the Commission to accept the current report from Staff rather than all the parties and for the Commission to direct Staff to file monthly status reports beginning August 31, 2016, and on the last working day of each subsequent month until otherwise ordered.

The Commission finds the Staff's request reasonable, and will grant it.
