Attached are AmerenUE's responses to the requests you distributed on August 4th. Specifically, we have provided the following:

- Document outlining those areas of the rule we believe to be too prescriptive (outside of filing requirements addressed separately)
- Assessment of the filing requirements under each section of the rule
- Response regarding the processes we would keep in place to ensure that stakeholders are able to get the relevant information they need to assess our IRP filings (outlined below)

Processes to ensure access to needed information:

- **Stakeholder engagement process**, both prior to and after the filing of the IRP – provides for review of key inputs and conclusions during the analysis and development of the filing and discussion of questions and issues after the filing
- **Data request process** – provides for specific information requests for items otherwise not provided
- **Access to work papers** – provides for access to detailed information that is impractical to include in the filing
- **Annual update process** – provides update on status of implementation and critical uncertain factors and changes in market conditions that may affect the plan

While we hope you and others involved in the process find this information useful in advancing the revision to the Chapter 22 rules, we also need to reiterate that clearly defining the objectives of the IRP process is a critical step toward defining the rules more specifically and will AmerenUE to determine what it believes should be encompassed within a good rule. In recognition of this need, we continue to work diligently on our review of the "Objectives" document that has been circulated and look forward to hearing the ideas of the other parties.

We appreciate the measured approach that Staff is taking to ensure that we get rules that serve a clear purpose
