## ORDER DIRECTING CLARIFICATION

On May 24, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting that Rosebud Telephone, LLC's certificate of service authority to provide basic local, non-switched local, and interexchange telecommunication service in the State of Missouri be cancelled. The Commission granted Rosebud certificate of service authority to provide basic local, non-switched local, and interexchange telecommunication service in the State of Missouri in File Number LA-2010-0298.

Staff's motion states that Rosebud notified Staff on May 14 that it no longer wished to retain its certification to provide interexchange telecommunications services in Missouri. The motion does not represent that Rosebud wished to relinquish its certification to provide basic local or non-switched local service.

The Commission will direct Staff to clarify which certifications Rosebud seeks to relinquish. If Rosebud submitted its request to relinquish in writing, that writing should be attached to Staff's clarification.

**THE COMMISSION ORDERS THAT:**

1. Staff shall clarify its Motion to Cancel Certificate of Service

Authority as described in the body of this order no later than June 12, 2018.

2. This order shall be effective when issued.
