ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

On June 17, 2003, the Staff of the Missouri Public Service Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of PTT Telekom, Inc. Staff notes that the Commission granted PTT Telekom a certificate of service authority to provide intrastate interexchange services in Case No. TA-98-51.¹

Staff states that telecommunications companies are required to file a Missouri-specific annual report pursuant to Sections 392.210 and 392.390.1, RSMo 2000. According to Staff, the company is also required to keep the Commission informed of its current address and telephone number. Staff indicates that PTT Telekom's 2002 annual report form was returned by the post office as "undeliverable." Staff further notes that the Missouri Secretary of State's website shows that the company was administratively dissolved on August 2, 2001, for failure to file an annual report. Staff asserts that PTT Telekom has violated the terms of its certificate by its failure to keep the Commission informed of its current address and by its failure to file its annual report.

¹ A review of the Commission's records indicates that the tariff was also approved in Case No. TA-98-51.

On August 1, 2003, the Commission issued an order directing Staff to address certain issues regarding notice. Staff complies on August 5, 2003. Included in Staff's response are copies of several returned certified mail receipts.

Commission Rule 4 CSR 240-2.080(15) states that parties are allowed not more than ten days from the date of filing in which to respond to any pleading, unless otherwise ordered by the Commission. More than ten days have passed since Staff filed its motion and PTT Telekom has not filed any response.

Section 392.210, RSMo 2000, states in part: "Every telecommunications company shall file with the commission an annual report . . . covering the yearly period fixed by the commission." Section 391.390.1, RSMo 2000, states in part: "[A telecommunications company shall file] annual reports with the commission as required by the commission and in a form and at times as prescribed by the commission." Finally, under Section 392.410, RSMo Supp. 2002, the Commission has the authority to cancel a telecommunications corporation's certificate.

The Commission finds that the certificate of service authority granted to PTT Telekom, along with the accompanying tariff, should be canceled.

IT IS THEREFORE ORDERED:

- 1. That the certificate of service authority granted to PTT Telekom, Inc., in Case No. TA-98-51 is canceled.
 - 2. That the accompanying tariff filed by PTT Telekom, Inc., is canceled.
 - 3. That this order shall become effective on September 28, 2003.

4. That this case may be closed on September 29, 2003.


