
**JOINT STIPULATION REGARDING ADMISSIBILITY OF FILED
TESTIMONY**

Both parties agree that neither party will file a motion to strike testimony on the grounds that the testimony in question may address legal concepts (e.g., statutes, rules or decisions) or policy concepts (e.g., interpretation of statutes, rules or decisions). Further, neither party would assert such "legal opinion" or "legal conclusion" objections to testimony when the testimonies are offered into evidence at the hearing.

In the interest of a clear understanding as to the scope of our foregoing agreement, while each party is agreeing not to file a motion to strike or to object to admissibility on the grounds that the subject testimony contains legal opinions or conclusions, each party reserves and does not waive its rights to object to admissibility of the testimony on other grounds, or to contest the correctness of the content of such testimony and conclusions. Further, by making the agreement in the preceding paragraph, the parties do not agree that any legal or policy statements or opinions contained in that testimony are consistent with the law or a proper interpretation of applicable law.
