ORDER CANCELING CERTIFICATE AND TARIFFS

Issue Date: April 25, 2006 Effective Date: May 5, 2006

This order cancels the certificate of service authority to provide intrastate, interexchange, basic local and nonswitched local telecommunications services granted to UpLync Telecommunications, Inc., along with its accompanying tariffs.

On April 14, 2006, the Staff of the Commission filed a motion to open a case and to cancel UpLync's certificate of service authority and accompanying tariffs. Staff's motion indicates that UpLync has contacted Staff and has requested that it be allowed to relinquish its certificate in Missouri. The company told Staff that it is no longer in business and is not providing telecommunications service in Missouri. Staff confirms that the company owes no assessments or annual reports. The Staff also notes that no formal complaints have been filed with the Commission against UpLync since the commencement of the Electronic Filing and Information System.

The motion states that the Commission granted UpLync a certificate of service authority to provide intrastate, interexchange, basic local and nonswitched local telecommunications services in December 2003, in Case No. LA-2004-0136. The company's basic

local and nonswitched local tariff, Mo PSC No. 1, and its intrastate access tariff, P.S.C. MO. No. 2, were approved in the same order.

Staff served copies of its motion on UpLync, and its registered agent, Mike Bristol, but the company has not filed a response.

The Commission has the authority to cancel a telecommunications corporation's certificate under Section 392.410.5, which states, "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." Since no one has requested a hearing, the Commission may grant the relief requested based on Staff's verified motion which is entered into evidence.

Based on Staff's uncontested motion, the Commission finds that UpLync's certificate and accompanying tariff should be canceled.

IT IS ORDERED THAT:

- 1. The certificate of service authority to provide intrastate, interexchange, basic local and nonswitched local telecommunications services granted to UpLync Telecommunications, Inc., in Case No. LA-2004-0136, is canceled.
- 2. UpLync Telecommunication, Inc.'s basic local and nonswitched local tariff, Mo PSC No. 1, and its intrastate access tariff, P.S.C. MO. No. 2 are canceled.

- 3. This order shall become effective on May 5, 2006.
- 4. This case may be closed on May 6, 2006.
