### PARTIES' MARCH 29, 2019 STATUS REPORT

**COMES NOW** Staff of the Missouri Public Service Commission ("Staff"), by and through Staff Counsel's Office, Summit Natural Gas of Missouri, Inc. ("SNGMO"), and the Office of the Public Counsel ("Public Counsel") (collectively "the Parties"), and state as follows for their *March 29, 2019 Status Report*:

- 1. On December 28, 2018, Staff, SNGMO, and Public Counsel filed their December 28, 2018 Status Report in which Staff stated it was in the process of making certain determinations in order to send feedback to SNGMO and Public Counsel. Staff requested with the concurrence of SNGMO and Public Counsel that Staff's monthly status reports be suspended and that the Parties report to the Commission no later than March 29, 2019, respecting the progress made by the Parties.
- 2. Staff stated that it was in the process of making certain determinations in order to send feedback to SNGMO and Public Counsel and that Staff anticipated requesting that the Parties meet in the upcoming month of January 2019 to address the effect of those determinations.
- 3. Staff submitted a revised draft CAM to SNGMO and Public Counsel on February 6, 2019, and a meeting/conference call was subsequently scheduled for February 21, 2019, for purposes of discussing Staff's latest draft CAM, among other things. The meeting/conference call occurred and another meeting/conference call is scheduled for May 6, 2019.

4. The Parties request to May 28, 2019, an additional eight plus weeks, to continue consideration and discussions, and either file (a) an agreed upon CAM with the Commission, which resolves all outstanding and necessary CAM issues by that date, or alternatively, (b) a proposed procedural schedule providing an adequate number of days for an evidentiary hearing covering all outstanding and necessary CAM issues remaining among them.

WHEREFORE, the Parties submit their *March 29, 2019 Status Report* and suggest that the Parties report to the Commission no later than May 28, 2019, with an agreed upon CAM, or alternatively, a proposed procedural schedule that will be needed to resolve any outstanding and necessary CAM issues remaining among them.
