**MOTION FOR EXPEDITED TREATMENT**

COME NOW Matrix Telecom, Inc., (hereinafter referred to as "Matrix" or "Buyer") and Global Crossing Telecommunications, Inc., Global Crossing Local Services, Inc. and Global Crossing Telemanagement, Inc. (hereinafter referred to as "GC" or "Seller") (together the "Applicants"), by and through counsel, and for their Motion for Expedited Treatment pursuant to 4 CSR 240-2.060(17) hereby state:

1. On March 24, 2005, Buyer and Seller filed an application for authority to transfer assets (the "Application").
2. The transfer of assets, as described in the Application, is scheduled to occur as soon as the Commission approves the Transaction.
3. Applicants respectfully request the Commission to issue an Order approving the Application to be come effective as soon as possible. Specifically, Applicants request that the Commission approve the application with an order effective no later than May 15, 2005.
4. The proposed transaction is an important component of the Asset Purchase

Agreement entered into between Buyer and Seller on March 19, 2005. Accordingly, Applicants request that the Commission commence its review of this Application as soon as possible. It is in the interest of all parties – Matrix, GC, their customers, creditors and employees – that the reorganization process be completed quickly. Applicants have been mindful of the need to structure a transaction and proceed as quickly as possible to avoid any confusion or inconvenience to consumers. The public interest therefore supports commencement of the review process at this time.

WHEREFORE, for all the reasons stated herein, Applicants respectfully request that the Commission grant this Motion for Expedited Treatment and issue its order granting the relief requested in the Application with an effective date no later than May 15, 2005.
