ORDER CANCELING TRUE-UP HEARING AND SETTING TIME FOR OBJECTIONS TO TRUE-UP TESTIMONY

The procedural schedule issued February 3, 2021, directed the submission of true-up prefiled direct and rebuttal testimony, and scheduled the True-Up Hearing for August 23, 2021. On August 19, 2021, Spire Missouri, Inc. filed a *Motion to Amend Procedural Schedule and Status Update* explaining that no party has indicated a need for the True-Up Hearing. The motion also stated that Staff, OPC, and Spire have agreed to waive cross examination of true-up witnesses and requested the Commission admit the prefiled true-up testimony by order.

The Commission finds the request to cancel the True-Up Hearing is reasonable and will grant the request. The Commission will set a deadline for objections to the admission of the following testimony:
