**JOINT MOTION FOR ORDER APPROVING STIPULATION
AND AGREEMENT AND DISMISSING CASE**

COME NOW Laclede Gas Company ("Laclede") and St. Louis Natural Gas Pipeline LLC ("SLNGP") and jointly move the Commission for its Order approving their Stipulation and Agreement filed on September 30, 2011 and dismissing the present case with prejudice. In support of this Joint Motion, Laclede and SLNGP state:

1. On September 30, 2011, Laclede and SLNGP filed their Stipulation and Agreement resolving all issues in this case between them and requesting the Commission to issue an order approving all of the specific terms and conditions of the Stipulation and Agreement.

2. On September 30, 2011, Laclede and SLNGP filed a Notice Regarding Nonsignatory Parties to clarify that the nonsignatory parties had not yet reviewed the final stipulation and should retain their right to make objections pursuant to 4 CSR 240-2.115.

3. Pursuant to 4 CSR 240-2.115(2)(B), the remaining parties had seven (7) days after September 30, 2011, in which to file any objection to the nonunanimous stipulation between Laclede and SLNGP. No party filed any objection.

4. Pursuant to 4 CSR 240-2.115(2)(C), for lack of any timely objection, the Commission may treat the Stipulation and Agreement filed September 30, 2011 as a unanimous stipulation and agreement between all parties.

5. The Commission therefore may approve the Stipulation and Agreement and dismiss the present case pursuant to 4 CSR 240-2.150 and 4 CSR 240-2.116.

WHEREFORE, Laclede and SLNGP pray the Commission for its Order declaring the Stipulation and Agreement filed September 30, 2011 to be a unanimous stipulation, approving the Stipulation and Agreement, dismissing the present case with prejudice and for such other and further relief as the Commission deems just and proper.
