COME NOW MCImetro Access Transmission Services, LLC d/b/a Verizon Access Transmission Services ("Verizon Access") and Embarq Missouri, Inc. ("Embarq") pursuant to Arbitrator's Order and for their Joint Status Report state to the Commission and Arbitrator as follows:

1. Verizon Access and Embarq have signed and submitted to the Commission documentation confirming Verizon Access has adopted another Embarq interconnection agreement pursuant to section 252(i) of the Act.

2. Pursuant to Commission rule (4 CSR 240-3.513(4)), the adoption should be effective as of the date of submission to the Commission.

3. Once the parties have received confirmation that the adoption process is successfully completed, this arbitration proceeding will no longer be required and Verizon Access will be able to dismiss its Petition.

4. Verizon Access and Embarq will keep the Commission and Arbitrator informed as to status of the adoption and subsequent arbitration dismissal.

WHEREFORE, Verizon Access and Embarq hereby request the Commission and the Arbitrator to accept this Joint Status Report.
