- 2. Staff has failed to comply with the Commission's Order as it did not submit a revised Accounting Schedule #1 for any district.
- 3. Staff also failed to comply with the Commission's Order as it did not file a Schedule #1 demonstrating the contrast between the revenue requirement as determined by the Agreement and the variance created utilizing the allocation factors advocated by Intervenor City of Joplin.
 - 4. Staff has refused to comply with a specific order of this Commission.

WHEREFORE, Intervenor City of Joplin moves this Commission to enter its order directing Staff to produce the documents previously requested by this Commission or in the alternative to strike all Staff pleadings previously filed.
