

AMENDMENT #1
EFFECTIVE NOVEMBER 15, 1990
TO THE
WOLF CREEK INSURANCE MEMORANDUM
EFFECTIVE JANUARY 1, 1987

The parties to the Wolf Creek Insurance Memorandum wish to amend such Memorandum so as to provide for the purchase of a "joint policy" (as described in Section VI) under which the benefits shall not be apportioned based on the Owners' interest in WCNOCC.

Section VI-C is therefore amended to read as follows:

- "C. Benefits from a joint policy shall be due each covered Owner in proportion to its undivided ownership interest in the damaged property or other loss, except where the Owners have specifically designated a different apportionment methodology within the joint policy. Each Owner shall have the right to designate the coverages and limits desired and to designate any mortgagee, trustee or secured party as loss payee to the extent that such designations do not invade or impair the ownership interest of any other Owner(s), and entitlement of any Owner under insurance policies."
