ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: June 6, 2018 Effective Date: June 16, 2018

On May 24, 2018, the Staff of the Commission filed a motion requesting that Rosebud Telephone, LLC's certificate of service authority to provide interexchange telecommunication service be cancelled. Staff filed an amended motion on June 6, 2018 to clarify that Rosebud's basic local and non-switched local certificates should be cancelled as well.

The Commission granted Rosebud a certificate of service authority to provide basic local, non-switched local, and interexchange telecommunication service in File No. LA-2010-0298. Staff's motion states that Rosebud notified Staff on May 14, 2018 that it no longer wishes to retain its certification. A letter from a representative of Rosebud, attached to Staff's amended motion, confirms Rosebud's desire to relinquish its certificate of service authority. Staff recommends the Commission cancel the company's certificate of service authority.

On May 25, the Commission issued an Order Establishing Time to Respond, allowing parties until June 4 to respond or request a hearing. No response was filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority

may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, including the letters from the company, the Commission finds that the certificate of service authority granted to Rosebud Telephone, LLC, should be canceled.

THE COMMISSION ORDERS THAT:

- The certificate of authority to provide basic local, non-switched local and interexchange telecommunications services granted to Rosebud Telephone, LLC, in File Number LA-2010-0298, is canceled.
 - 2. This order shall become effective on June 16, 2018.
 - 4. This file may be closed on June 17, 2018.
