## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: June 19, 2015 Effective Date: June 29, 2015

On June 3, 2015, the Staff of the Missouri Public Service Commission filed a motion requesting Pac-West Telecomm, Inc. ("Pac-West") certificate of service authority and accompanying tariff to provide interexchange and competitive basic local telecommunication services in the State of Missouri be cancelled.

In File Number LA-2011-0283, the Commission granted Pac-West a certificate of service authority to provide interexchange and competitive basic local telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Pac-West contacted Staff via electronic communication stating Pac-West was no longer providing service in Missouri and requested the Commission cancel Pac-West's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange and competitive basic local telecommunications services, and the company's accompanying tariff.

On June 4, 2015, the Commission issued an Order Establishing Time to Respond allowing any parties to file an objection or request a hearing to do so no later than June 15, 2015. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Pac-West Telecomm, Inc., shall be canceled.

## THE COMMISSION ORDERS THAT:

- The certificate of authority to provide interexchange and competitive basic local telecommunications services granted to Pac-West Telecomm, Inc., in File Number LA-2011-0283, is canceled.
  - 2. Pac-West Telecomm, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
  - 3. This order shall become effective on June 29, 2015.
  - 4. This case may be closed on June 30, 2015.
