On April 18, 2016, the Staff of the Missouri Public Service Commission (Staff) filed a motion to cancel the basic local and interexchange telecommunication services of Charter Fiberlink-Missouri, LLC (“Charter Fiberlink”), in the State of Missouri.

On May 24, 2016, Staff filed its *Request To Withdraw Motion* based on a May 23, 2016 Company filing which stated Charter Fiberlink intend to continue providing telecommunication services in Missouri.
