**ORDER CANCELING CERTIFICATES AND
ACCOMPANYING TARIFFS**

Issue Date: December 18, 2015

Effective Date: December 28, 2015

On October 21, 2015, 3L Communications Missouri, LLC (“3L Communications”) filed notification for the discontinuance of services and requesting the Commission cancel their certificates of service authority and accompanying tariffs to provide telecommunications services in the State of Missouri.

In File Number TA-2012-0201, the Commission granted 3L Communications their certificates of service authority to provide telecommunications services in the State of Missouri, and approved their tariffs. Specifically 3L Communications was approved to provide competitive local exchange and interexchange telecommunications services. The Company’s tariffs, P.S.C. MO No. 1 and 2 were also approved.

On October 26, 2015, the Commission issued an Order Directing Staff to File a Recommendation. On October 30, 2015, Staff filed their recommendation and stated that 3L Communications no longer wished to obtain its certification to provide service in the State of Missouri. Staff recommends that the Commission cancel the

companies' certificates of service authority to provide telecommunications services and the companies' accompanying tariffs.


The Commission has the authority to cancel a certificates and tariffs pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on 3L Communications' request and Staff's recommendation, the Commission finds that the certificates of service authority and accompanying tariffs granted to 3L Communications Missouri, LLC, shall be canceled.

IT IS ORDERED THAT:

1. The certificates of authority to provide competitive local exchange and interexchange telecommunications services granted to 3L Communications Missouri, LLC, in File Number TA-2012-0201, are canceled.
2. 3L Communications Missouri, LLC's tariffs, P.S.C. MO No. 1 and 2, are canceled.
3. This order shall become effective on December 28, 2015.
4. This case may be closed on December 29, 2015.
